Automated External Defibrillator (AED) Donation Program - During FY24, Living for Zachary donated 203 Automated External Defibrillators (AEDs) to youth-based organizations across the state of Texas. These AED donations removed the financial burden from organizations looking to equip their buildings with this life-saving device and created more rescue-ready environments in the places children learn and play. AED recipients located in select cities also received free CPR training along with their AEDs. In total, Living for Zachary certified 713 people in CPR/AED use during FY24. Living for Zachary also established a new partnership with GoRescue, which now allows us to provide CPR training in cities outside of North Texas including San Antonio, Austin, Houston, Amarillo, Lubbock, Abilene, Waco, and Tyler.

Education & Awareness - Living for Zachary continued to provide education and awareness offerings in both in-person and online formats. Living for Zachary attended 65 community awareness events in FY24, and reached more than 57,000 people through social media platforms.

Youth Heart Screenings - From May 2023-April 2024, Living for Zachary's Heart Screening Program screened 416 youth. In total, Living for Zachary hosted 9 heart screening events in FY24 for youth ages 12-22 in North Texas. The screenings were provided by partners Baylor Scott & White The Heart Hospital and Frontera Strategies to families free of charge.

Scholarship Program - The goal of Living for Zachary's Scholarship Program is to reduce the financial burden of students entering the field of cardiac sonography with the goal of placing more professionals in this essential field. Living for Zachary awarded 5 student scholarships during FY24. These scholarships included one awarded to a student at Baylor Scott & White's Adult Echocardiography Program at The Cardiovascular Institute, and two awarded to students at Dallas College - El Centro's Adult Cardiac Sonography Program. Additionally, Living for Zachary awarded the Plano East Football and Athletic Training Scholarship in memory of Zachary Schrah.

SuperHeart Program - Living for Zachary's SuperHeart Program is a bundle of the AED, screening, and education/awareness programs and is designed to equip schools and youth-based organizations with the tools and resources to save lives from SCA on campus. In FY24, three schools/organizations were certified in the SuperHeart Program, impacting 2,119 students. 121 staff members at the participating organizations were certified in CPR use, 254 youth heart screenings were completed, and 6 AEDs were placed on campuses. The expenses associated with this program are reported within the individual elements of this bundle.

Dealing with potential conflicts and the level at which determinations of whether a conflict exists are made - Potential conflicts are considered at board and committee meetings much like actual conflicts.

Dealing with actual conflicts, the level at which actual conflicts are reviewed, and restrictions imposed on the interested person - To the extent that the affiliation

violates state or federal law, the Corporation shall not engage in business with that individual or entity, or shall terminate its relationship with the conflicted Associate. If the affiliation does not violate the law, the Board of Directors shall determine whether the Corporation can obtain with reasonable efforts a more advantageous transaction or arrangement from a person or entity that would not give rise to a conflict of interest. If a more advantageous transaction or arrangement is not reasonably possible, then the Board of Directors shall determine by a majority vote of the disinterested directors whether the transaction or arrangement is in the Corporation's best interest, and whether it is fair and reasonable.
